CLASS MEDIUM RIGID (MR) LICENCE UPGRADE - TRUCK COMPETENCY BASED ASSESSMENT (CBA) LICENSING SYSTEM

Medium Rigid (MR) - any motor vehicle with 2 axles and a GVM of more than 8t. Any towed trailer must not weigh more than 9t GVM.

The vehicle used by Royce is a Hino FD 16/SCR C Cab tabletop, 6 speed synchro gearbox with a GVM of 9.3t.

If you live in Sydney, the Central Coast or Newcastle, Competency Based Assessment is the primary method to upgrade to a Heavy Vehicle licence. You will be required to undergo a Knowledge Test at the RTA and be issued with a log book. CBA provides assessment under a wide range of driving conditions by an RTA accredited assessor.

The assessment is much more flexible than a driving test. Training and assessment is given in the following areas:

You will be given credit for the skills (called competencies) which you perform correctly, and repeat assessments are focused only on areas where you have had problems. Your successfully completed competencies are recorded in your *Heavy Vehicle CBA Learner's Log Book*.

During assessment you will have competencies evaluated to make sure that your driving is both safe and consistent. Some competencies are required to be assessed more than once. This is to make sure you have developed good driving habits. After each session, your assessor will 'sign off' each successful competency in your Log Book. You will then only need to concentrate on completing any outstanding competencies. For any competency to be signed off, you must demonstrate it without any errors.

You can decide to have a 'one-off' assessment or to be progressively assessed while you are taking instructions.

The CBA system is favoured by the Transport Industry because the thorough training and assessment prepares drivers to be more professional and have the correct skills to operate heavy vehicles on today's roads.

Age and tenure requirements for learner drivers: Before you can learn to drive this type of vehicle you must be at least 17 years and must hold a licence (other than a learner's licence) in NSW or elsewhere. This can be any class of licence other than a rider's licence.

Age and tenure requirements for fully licensed drivers: Before the MR driver's licence can be issued you must be at least 18 and must have held a licence (other than a learner's licence) to drive a vehicle other than a motorcycle for a period of, or for periods totalling, one year.

How the system works:

- * It is a requirement that the RTA knowledge test be passed **before** a heavy vehicle CBA log book can be issued.
- * Go to your local RTA, and on successful completion of the knowledge test, collect:
 1. Heavy Vehicle CBA Learner's Log Book.
 2. Guide to Heavy Vehicle Competency Based Assessment
- * Contact Royce Training Group to organise training
- * Our trainer/assessor will see you for your CBA sessions.
- * Your assessor will report completed competencies directly to the RTA. When your log book has been completed for all the competencies, you can go to any motor registry for the issue of your licence. The RTA will keep your Log Book. Remember, you do not need to take a driving test.
- * We will issue a 'Statement of Competency' to you. This has details of the vehicle in which you were trained. It may be used as a Reference.
- * Clients must meet their trainer/assessor at our premises (unless organised otherwise).
- * 24 hours notice required for cancellation.
- * Appropriate footwear must be worn.
