If the applicant is deemed Not Competent at the completion of assessment tasks, a further fee is applicable, charged at the hourly rate. (see * below for further explanation)

One Day Course applicants must provide Royce Training Group with their licence/log book details when booking as 72 hours notice must be given to the RTA before Final Competency Assessment (FCA) can be booked. Day Courses commence between 0700 and 0800. The FCA is conducted in the final 40 minutes of the course, and is pre-booked for between 1520 and 1620 on the day. The RTA allows us to alter this booking if extra assessment time is needed by postponing it for a further hour. If this is necessary, * the hourly rate is applicable for clients upgrading to LR or MR, but is not charged if upgrading to HR Auto.

Royce Training Group requires a 50% deposit for One Day courses. This is not refundable unless 48 hours notice is given.

It is recommended that the Guide Book be studied prior to lessons. Lessons can commence when all RTA requirements have been met. RTA fees of approximately \$120 for the knowledge test, log book and photo licence are applicable.
